CONTINUING PERSONAL GUARANTY OF PAYMENT OF ACCOUNT

In consideration of the sale of materials and supplies and the extension of credit and financial accommodations to buyer named above, the undersigned guarantors agree as follows:

1. Guarantors do hereby jointly and severally unconditionally guaranty the full, prompt and complete payment by buyer of all indebtedness to seller for sales on the account of buyer and all further advances and extensions of credit which may be made by the seller to buyer and any other indebtedness of buyer to seller, whether secured or unsecured.
2. The obligations of guarantors hereunder are not limited to any particular period of time but shall be an absolute continuing and unlimited guaranty of payment, without regard to regularity, validity or enforceability of any particular obligation of buyer hereby guaranteed. This guaranty shall continue until all indebtedness of buyer to seller has been fully and completely paid or otherwise released, discharged or forgiven by seller, and guarantors shall not be released of any obligation or liability hereunder so long as there is any claim of seller against buyer arising out of buyers account with seller or any other indebtedness of any nature whatsoever of buyer and seller.
3. The obligation of guarantors are independent of the obligations of buyer, and a separate action or actions may be brought and prosecuted against guarantors or any of them, whether or not actions are brought against buyer or to foreclose on any security held by seller or whether buyer is joined in any such actions, guarantors waive the benefit of any statute of limitations affecting their ability hereunder of the enforcement of this guaranty. This guaranty shall be enforceable by and against the respective administrators, executors, successors and assigns of guarantors, and the death of a guarantor shall not terminate the liability of such guarantor or limit the liability of the other guarantors under this guaranty.
4. Guarantors authorize seller without notice of demand or consent of guarantors and without their liability hereunder or the enforcement of this guaranty from time to time to (i) renew, compromise, extend, accelerate, revise, alter, amend or otherwise change any or all of the terms, covenants and conditions of the account of buyer, including without limitation the time or date of payment of the indebtedness, the amount of such indebtedness, or the method or manner of payment of such indebtedness. (ii) take and hold security from buyer or others for the payment of this guaranty or the indebtedness guaranteed and exchange, enforce, waive, or release all or any portion of such security, (iii) apply such security and direct the order or manner of sale thereof as seller in its discretion may determine, and (iv) release or substitute any one or more e of guarantors.
5. Guarantors waive any right to require seller to (i) proceed against buyer; (ii) proceed against or exhaust any security held from buyer, or (iii) pursue any other remedy in law or equity with respect to the obligations of buyer and guarantors to seller. Guarantors waive any defense arising by reason of any disability or other defense of the buyer by reason of the cessation for any cause whatsoever of the liability of buyer. Guarantors waive any right to claim exoneration or discharge by reason of any set or omission of seller, except the payment in full by buyer of all indebtedness owing to seller. Guarantors waive all demands of presentment, demands for performance, notices of nonperformance, protests, notices of protests of dishonor, notices of this guaranty, and notice of any further advances and extensions of credit buy seller to buyer or the creation or any other indebtedness of buyer to seller.

Guarantors hereby agree to pay in addition to all the foregoing all attorneys' fees and costs and expenses incurred by seller with respect to buyers obligations to seller and the enforcement of the guaranty, including without limitation service of process, filing fees, court and reporter costs, investigative costs, expert witness fees, appraisal fees, trustee and master fees, receivers' fees, and the cost of any bonds, whether otherwise taxable or not, incurred by seller, (i) in any action or proceeding pertaining to the account and any other indebtedness of buyer, payment of which is guaranteed hereby, (ii) to obtain a judgment against guarantors and/or buyer for all or any portion of the obligations and indebtedness guaranteed hereunder; (iii) in enforcing any judgment which may be obtained in such proceedings, including without limitation the judicial sale under mechanics lien laws, or any appeal from such proceeding, (iv) in representing seller in any proceeding under the California probate code, or in connection with any state or federal tax liens, or for the appointment of receiver, and (v) in representing seller in federal bankruptcy proceedings or state insolvency proceedings, or any other creditors' arrangements or creditors' proceedings initiated by or against guarantors and/or buyer.
